born in Pompek, Lomza, Poland, on Oct. 28, 1892

was married on July 10, 1918, at Worcester, Mass.; she was
born at Libinski, Vilna, Poland on February 18, 1897, entered the United States
at New York, N.Y. on January 28, 1924, for permanent residence therein, and now
resides at Worcester, Mass. I have five children, and the name, date and place of birth,
place of residence of each of said children are as follows: Katolija, Feb. 4, 1920; Raymond,
U. S. 1921; Jane, Oct. 6, 1922; Frank, May 28, 1924; and Henry, May
